Hilltop Park was also discussed and it has a lot of green space and it is not utilized as much. There is a rink in the winter, however it seems the parking lot is used more by the surrounding apartments than park users. Member Boor also gave a brief Shady Oak Lake update. Member Boor and member Wilkus will be meeting about Valley Park.
